PRESIDENT'S REPORT

It's been another eventful year in umpiring in BC. It is a great time to celebrate our successes, and build on our experience as we plan for an even better 2008.

You'll read a lot of good content in this issue of Hey Blue. And that includes some changes to Hey Blue itself – even though we already have one of the best communications vehicles in our sport.

There's a note from Steve Boutang regarding Don Hass, (thanks, Steve!). We are enormously proud of all that Don has accomplished as one of the top international umpires in Canada, and as a member of our community. We hope his recovery progresses as fully and as quickly as it can. I'd also like to recognize a number of our members who've provided any support they can to Don and his family.

We've started on another change this year -- Howard Chapman gave us lots of lead time, and let us know that he would be stepping down as Provincial Supervisor of Umpires in 2008. This Association and Baseball BC together went through a selection process to find a successor, and I'm very pleased to report that Richard Christie will be the new Supervisor. He became Assistant Supervisor earlier this year, and is working with Howard on the transition process. And Howard will remain involved! We are working on plans to keep Howard engaged in umpire development, doing the mentoring and evaluating, especially of young umpires, that is his special talent.

Our involvement with the national program is much improved. We've aligned our three-man positioning with the national standard. We hosted a successful Caravan this year, and we now have more, better-qualified instructors at all levels. We had seven umpires pass the level four exam, and join the roster of umpires eligible to do nationals in 2008. In 2007, we had eight umpires selected for nationals in Quebec City, and an assistant supervisor.

Our many educational activities achieved good results in 2007, with SuperClinic, an advanced clinic and our level 1 and 2 clinics all operating. Members had many opportunities to work baseball at different levels, and tournaments including provincials. Umpire availability for provincials is sometimes a challenge, and especially so this year when all of the higher-level provincials were held on the August long weekend. Many thanks to the umpires who worked!

Finally, a big thank you to Troy Carmont, who became our Treasurer mid-year upon Richard's appointment as Assistant Supervisor. And to Arne Pederson, who stepped in as Area Representative for Area 5, Lower Mainland South.

I hope to see many of you at our AGM!

VICE-PRESIDENT'S REPORT

This was my first year serving as the Vice President of our organization and I note three areas of my responsibilities that are most worthy of a report.

Earlier in the year we hosted a Caravan for the first time since 1993. This is a Baseball Canada program designed to develop instructors. We have pledged to jointly participate in this program with Alberta every 2 years. We hosted in 2007 and Alberta will reciprocate in 2009. Eleven of our members were joined by 6 from Alberta to participate in this event. In addition 2 more of our members participated as part of the faculty. The attendees were:

Brian Cargnelli from the Okanagan and Richard Christie from the Lower Mainland joined 4 instructors from out of province. This event took place over a 4 day period starting the evening of January 25 and ending the afternoon of January 28. An exceptional amount of information was presented and needed to be processed by all of the participants. Many felt overwhelmed despite the fact that they were apprised of the commitment. I do not think that they truly believed the involvement that was expected of them until they were in the thick of it. Regardless, most reported having learned a great deal and ultimately improving their abilities as instructors. I would like to offer my thanks to all of the participants who took time and effort to ultimately benefit our association.

Special congratulations go out to Rob Allan who achieved his Senior Course Conductor status despite the fact that this was his first time attending Caravan.

This has become a greater challenge than ever before. The curriculum is far more intense than in past years and as such the criteria for success is certainly more onerous. Rob joins Mark Bodwell, Don Hass, Kevin McDonald, Fred O'Rourke, Fabian Poulin, Perry Roussy, and Jerry Tregaskis who had achieved their Senior Course Conductor status in previous Caravans. Also, as a result of his performance as an instructor, Brian Cargnelli achieved his Master Course Conductor status and joins Richard Christie and Howard Chapman who had previously reached this plateau.

In addition to the obvious benefit of improving our instructional techniques, this program affords us more visibility in the Baseball Canada community and hopefully a greater participation for our members in prestigious National and International assignments. I hope that our association has both the will and resources to continue its participation in this program.

Another area that has improved somewhat, but not enough, is the filing of 'Ejection Reports.' This is still short of the mark. I get every single report that is filed with our organization, and I know that there are more ejections than reports. We had a serious situation with a coach who threatened the life of one of our umpires in earshot of several witnesses. The coach's defence was that he said it in the heat of the moment and did not mean it. I heard a lot of rhetoric about all of the times that this particular coach was ejected, however, we were not able to corroborate it because we did not have the reports on file. Demonstrating this individual's propensity for unacceptable behavior was not possible. As such, the severity of his discipline was likely less than what would have otherwise been meted out if we had the proper paper trail to present.

If you do not file a report with BCBUA,

the ejection is treated as though it did not happen, and one day it may come back to bite you in the lower region of your backside. Not filing the report is an abdication of your responsibility to yourself, to your fellow umpires and to the sport of baseball itself. We have tried to make it as easy as possible by having one form for all ejections posted on our website, however, if you have any suggestions to make it even easier please let me know.

Another one of my responsibilities as Vice President is to chair the Discipline Committee. This season we received complaints against 3 of our members. Two of the complaints were withdrawn. The third was very serious and was referred to a committee to be investigated. I was unable to chair this committee as I was away at the time. As such, Richard Christie was appointed to chair the committee and recruited Troy Carmont and Howard Chapman to sit on the committee with him. I would like to thank all three for stepping up to the plate. The in depth investigation yielded no corroboration of the complainant's accusation and as such the umpire was absolved of any wrong doing.

We will be holding our next Annual General Meeting on Sunday, November 18, 2007 in the Lower Mainland and the details are published elsewhere in this issue. Please make an effort to attend.

Well this has been an interesting year indeed in the Thompson Okanagan zone. Salmon Arm and Kamloops once again hosted BCBUA clinics this past year and a total of 56 people in our area are now full members of this association. Big time Kudos goes to Dennis Stockford of Salmon Arm and Rob Kloster of Kamloops for organizing and hosting these clinics. Without these two guys doing some of the on-site preparation there is no way we could ever offer instruction in either of these cities. I would also like to welcome those new members in Chase who either travelled into Kamloops or to Salmon Arm to take part in one of these clinics. Great to see that type of commitment to your education of baseball officiating. And I would also like to recognize Rob Kloster, Chris Connelly, Matt Lowndes, Kris Hartley and Kelly Hunter of Kamloops who all travelled to New Westminster last February to attend the 2 day Superclinic that BCBUA hosts every year. This is an advanced level clinic that offers the students who attend a higher level of instruction than can be offered at a local level 1-2 clinic. If you want to take your officiating to another level next summer and you are at least a level 2, there is information on the BCBUA web site (www.bcbua.ca) that will explain this clinic in detail.

Another big achievement for our area this past year was that Chris Connelly attended the Baseball Canada National Caravan and achieved his Novice Instructor status. The Caravan is one of the most intensive workshops that Baseball Canada puts on and is designed to teach people how to instruct an umpire's clinic under the NUCCP. Chris was the youngest attendee by several years and as one of the instructors of this clinic, I can tell you he did our region proud. Well done Chris! BCBUA is in the process of planning on hosting another Caravan in the future and we will train more people from our region to be National Level instructors. We are also planning on hosting a Provincial Instructor Clinic early in the spring of 2008 and are looking for people who want to learn to instruct our Level 1-2 clinics. Yours truly will be one of the instructors and I am sure we will also utilize the newly learned skills of Chris and the other 10 people from this province who attended the Caravan in helping train the next group of instructors for the BCBUA.

As I mentioned above, several people from Kamloops attended the Superclinic this past February. Three of these people, Chris Connelly, Matt Lowndes and Kris Hartley wrote and passed their Level 4 Exam. These 3 then were field rated this past summer and all 3 achieved their full Level 4 standing. This is the first time that an interior town (Kamloops) can boast of having 3 Level 4 and one Level 5 official.

To Umpire Championships or not to Umpire Championships; that is the question. by Danny Huzar

The umpire who made that statement was probably a real poor official who tried to get his paycheck and hide behind his partners and stay out of trouble all his life. Control of the ballgame is the difference between umpires that show up for the players and the managers." -National League Umpire Bruce Froemming

Although I do not fully agree with the above statement made by Bruce Froemming, it does have a modicum of truth attached to it. Some umpires get to a comfort zone and are afraid to leave it.

The umpires on these 2 pages have been noticed. Their game is getting better all of the time. As their game improves, the assignments that are offered to them increase in stature. Officiating at a high level such as a Provincial, Western Canadian, National or International Championship, not only rewards officials but helps further their skill set. The feedback that umpires receive at these championships encompasses far more than you may expect to get at your local levels.

In the past few years the number of umpires that apply for these tournaments has dwindled. We have speculated as to what the reasons for this may be. I now think that one of the primary reasons is that like the umpire that Bruce Froemming was referring to in the quote above, some umpires are afraid to be noticed. They are afraid to put their egos into a vulnerable arena and potentially be crushed. If that is the reason that you have not applied for a high profile tournament, please reconsider immediately. The feedback that you will receive is constructive not destructive. It is intended to improve your game, to make you a better umpire and capable of doing higher level ball.

However, when you apply for a championship tournament, try to be realistic. It is unlikely that you will be assigned to a Senior tournament if you do not regularly work that level of ball in the regular season. However, if you are willing to work your way through the ranks, we have supervisors that will be delighted to assist you. These experiences will be highly rewarding in regard to your development as an umpire. We all may improve our games. No one has yet reached perfection, so sign up for next year and take the next step in your personal development.

COMMITTEE REPORTS

Education

-Steve Boutang, Chairman

As we reflect on the past season I would like to update you all on the advancements we have made in the area of Education in this province over the past year.

BCBUA has spent significant monies in the area of Education this year. And when I say that we 'spent' money I really mean that BCBUA lost potential revenues because we operated clinics at a loss or purposely without making money as we have in past years. Despite this being poor business, it made sense to us to provide a bigger bang for our collective dollars in the value we hopefully provided to up and coming umpires.

Beginning last January, BC hosted Caravan. This training seminar for our course conductors provided National certification for 10 of our members, including Sr course standing for Rob Allan. This means that Rob will be able to supervise at National tournaments and help train our up and coming course conductors. Brian Cargnelli was also awarded Master Course conductor status which allows him to not only supervise at National tournaments, but becomes one of the country's top trainers of course conductors and will lead the development of all course conductors in BC. Congratulations guys.

Superclinic was a huge success. The goal was to put on an Educationally sound learning experience regardless of cost. Superclinic was run with a 'break-even' goal, rather than being a money-maker for BCBUA. Judging by the positive commentary received, this was accomplished with great success. We hope to provide another value-for-dollar experience this coming February in Vancouver. Dates and locations are to be announced soon.

Level 3 umpires in the Interior were also provided with a higher education experience with an Advanced Level 3 clinic in Kelowna. 20 umpires took part. This clinic also ran at break-even.

Level 1 and 2 clinics were conducted in more remote areas than we have visited in past years and these clinics operated at a loss. Again, this is a valuable service being provided to our old and new members in these areas. More user friendly clinics were held, particularly in the Lower Mainland. The popular evening sessions were expanded this year to encompass most of the Vancouver clinics. We are hopeful that the retention level will improve as a result of the many short sessions as opposed to the single day long session. And we hope that we will get more members attending clinics as a result because there are many opportunities to attend rather than a single day. All of these clinics cost much more money to put on because we have to pay honorarias to several clinicians over several nights. This was a decision that was taken knowingly by your area reps and board members as we attempted to improve the quality of education in this province.

In the coming season we will continue to strive to improve the quality of education in this province. Financially we may have to adjust how we pay clinicians or make other adjustments in our organization as we ensure the continued viability of the BCBUA.

LEVEL 3 REPORT

-Bill MacMillan, Coordinator

2007 was a year of innovations in our attempts to deliver the Level 3 program to all of our members. We had mixed success but overall we finished with more Level 3 umpires in BC than we have had for several years and the potential to retain a higher number for next year.

We delivered two Advanced Clinics this year. The Super Clinic was held in New Westminster at Douglas College and an Advanced Clinic was held in Kelowna. The second one was a departure from the policy established a few years ago as a cost saving measure in that we would only hold a Super Clinic. We realized, however, that this policy was depriving some of our members of the opportunity to advance their skills by imposing a significant financial burden on them in the form of traveling costs. The Rutland, Kelowna and Penticton organizations stepped up to the plate by combining to defray a significant portion of the clinic costs and therefore make the Kelowna Advanced Clinic a success. Many thanks to them and as a result we are looking for ways to duplicate this effort somewhere on the Island in 2008. We had a combined attendance of 77 members and 10 instructors for these two clinics.

Our next efforts then were to increase the number of members that wrote the Level 3 exam and gave themselves the opportunity to advance. First, we reduced the cost of a Level 3 membership to \$65 from \$75. Next we introduced a third opportunity for our members to write and submit the Level 3 exam. Prior to 2007 (2008 exam year) we only had electronic or mail in exams but this year we allowed a time block at each of the Advanced Clinics for the exams. 31 members took this opportunity to write the 2008 Level 3 exam and 14 members wrote the 2008 Level 4 exam. Over all we had 55 Level 3 exams submitted for 2008 and only 5 of those did not pass.

At the Convention in 2006 we allocated \$100 for prizes as an incentive for members to get their exams in before May 20th so that the Provincials committee would have as complete a list of qualified umpires to assign as possible. Jerry Tregaskis provided the Ron Luciano trilogy from the BCBUA Library (we had extra copies of each) and we purchased The Illustrated Rules of Baseball by David Nemec giving us four prizes. On the 21st of May I had my lovely wife draw four names from those that had already submitted their exams and we shipped of the books to the lucky winners. The winners were David Miles (The Umpire Strikes Back), Bobby O. (Strike Two), Jim Train (The Fall Of the Roman Umpire) and Norm Robinson (Illustrated Rules ob Baseball). Congratulations to all the lucky winners.

The last and certainly most difficult of the facets of a Level 3 qualification to obtain is the Field Evaluation. Not because it is the

most difficult to perform but because it is the most difficult to arrange. The Area Rep. must coordinate both the umpires and the evaluators so that everyone is where they need to be at the same time. This is much easier in a tournament setting than a single game basis but not everyone can be assigned to the appropriate level of tournament. This leaves the onus on the umpire that requires their tri-annual (once each 3 years) evaluation to contact their Area Rep. to a) find out if they need one and b) arrange to have it done. The Area Reps are very busy and are not trained Baby Sitters so don't get complacent and assume that you don't need an evaluation. Find out!

We don't have all of the evaluations in from the Fall Classic and the various Provincial Tournaments yet but I can tell you that we had fewer than a dozen requests province wide for out of tournament evaluations this year. That is not enough, Be Proactive! Make it happen!

Let's end this on a positive note. In 2007 we had more qualified Level 3 umpires (44) than we have had in a good many years and our contingent of Level 4 & 5 umpires increased also. We are making progress. Good Luck and see you on the diamond next year.

NOTICE OF MOTION

The following is a motion which was endorsed by the Board of Directors last Fall but was not published in *Hey Blue!* in time to be ratified at the 2006 AGM. It will be presentes for ratificationat the upcoming 2007 AGM.

GUIDELINES FOR LIFE MEMBERSHIP

The following statements are the recommendations that are put forward as Guidelines for future nominations of Life Membership for umpires within the BCBUA.

- 1. That each person nominated for Life Membership have been a member of the BCBUA for a cumulative total of at least 10 years.
- 2. That each person nominated for Life Membership have made a significant contribution to his local area or association such as serving as an umpire in his area, or an Umpire in Chief/Umpire Supervisor for his association.
- 3. That each person nominated for Life Membership have made a significant contribution to the BCBUA as a whole by either serving on the elected Board of Directors with distinction or by completing several special projects on behalf of the association.

The following statements are the recommendations that are put forward as the Process for selecting Life Members for umpires within the BCBUA.

- 1. The name of a prospective Life Member must be forwarded, in writing, to any member of the elected board. The nomination must be complete with the credentials of the individuals and the reasoning for the nomination of Life Membership.
- 2. Upon receipt of the name of a prospective Life Member, that person's name will be brought forward at the nearest meeting of the Board of Directors.
- 3. At this meeting, the President shall accept the name of the prospective Life Member and appoint the Chairman of a selection committee to review the credentials of the person named.
- 4. This Chairman may or may not be a member of the elected Board of Directors, but must be someone who is a long time and well-respected member of the umpire community. He must be a member of the BCBUA.
- 5. This Chairman must then name 2 members to the selection committee to deliberate the person's credentials.
- 6. The 3 person selection committee must be made up of at least 2 members of the elected Board of Directors.
- 7. At the following meeting of the Board of Directors, the Chairman of the selection committee will forward a recommendation to the elected Board of Directors to either accept or not accept the person for Life Membership.
- 8. The elected board will then vote on the recommendations of the selection committee with majority requirement to carry the recommendation.


