Please note effective immediately, Baseball BC is moving all in person baseball programming back to Phase 3 with additional restrictions and requirements as per both the Provincial Health Officer Orders and the viaSport announcements this week.

Additional restrictions / requirements and measures have also been implemented as a result of new Provincial Health Officer Orders issued on November 19, 2020 in response to the ongoing COVID 19 pandemic. The Orders issued are for a two-week period ending at midnight on Monday December 7, 2020. These Orders are open to extension by order of the PHO.

Additional restrictions / requirements and measures required at this time are as follows:

- Spectators are not permitted.
 - This means no spectators at any games, competitions, training, or practice.
- Travel outside your home community is not permitted.
 - This means no one can travel to, from, and between communities for games, competitions, training, or practice.
- Masks are required in all indoor public settings.
- Strength training and dryland training are not permitted, unless there is a COVID 19 Safety Plan is in place for this type of activity that is strictly followed (see Regional Health Authority for your local requirements).

Please also be reminded of the following;

- Verbal symptom screening and attendance tracking must be performed daily.
- Stay home if you're sick.
- 2m physical distance required between participants at all times.
- All government expectations and requirements to be met, including viaSport Phase 3

Guidelines and the current PHO Orders.

All member groups and local associations are also required to review the new PHO orders and review and revise respective COVID-19 Safety Plans and policies and adapt where necessary.
